

Privacy Policy

Thank you for visiting our website. This Privacy Policy ("Policy") applies to www.aerionmap.com ("Site"), and Aerion Mapping Solutions LLC ("AMS") and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to AMS include www.aerionmap.com. The AMS website is an informational site. By using the AMS website, you consent to the data practices described in this statement. If you do not agree with any term in this Policy, please do not use the Site or provide any personal information to us as your use of the Site constitutes acceptance of this Policy.

Collection of your Personal Information

In order to better provide you with products and services offered, AMS may collect personally identifiable information such as your First and Last Name, Mailing Address, Email Address, Phone Number, Employer, and/or Job Title.

If you purchase any products or services from AMS, billing and credit card information may be collected. This information is used to complete the purchase transaction.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain information to us when you elect to use certain products or services. Sharing Information with Third Parties

AMS does not sell, rent, or lease its customer lists to third parties.

AMS may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to AMS, and they are required to maintain the confidentiality of your information.

Automatically Collected Information

AMS may automatically collect information about your computer hardware and software.
